Introduction

MSME Sustainable (ZED) Scheme is an extensive drive to create awareness amongst MSMEs about Zero Defect Zero Effect (ZED) practices and motivate and incentivize them for MSME Sustainable (ZED) Certification while also encouraging them to become MSME Champions. The MSME Sustainable (ZED) Certification aims at enhancing the competitiveness of an MSME by assessment, modification through guidance, handholding, managerial and technological intervention – not just certification. ZED Training Programmes

The training programs are one of the most important components of the ZED scheme as the ZED Master Trainers, Assessors and Consultants will play a pivotal role in ZED awareness programmes, trainings, assessment & certification and consultancy. To qualify as a ZED Mater Trainer, Assessor or Consultant, the interested professionals shall require to attend and successfully complete the requisite 5-day training programme.

This document lays down the eligibility criteria (**refer Annexure 1**) for applicants to participate in the ZED training programmes.

Selection of Participants

Resumes of applicants will be screened as per the prescribed eligibility criteria and short-listed candidates will be invited to undergo the training programme.

Note: 1. *Regarding applications for Assessor Training* - Preference will be given to the applications nominated directly by Certification Bodies/Inspection Bodies

Note: 2. An individual can apply for **either** 'ZED Assessor Training' **or** 'ZED Consultant Training' if applying in addition to 'ZED Master Trainer Training' programme.

Participation fee

There shall be no participation fees for undergoing the training programmes under the ZED scheme of MoMSME. It is to be noted that no TA/DA will be provided to the participants. Participants shall arrange travel & stay on their own.

Evaluation, Examination & Certification

During the training, participants will be evaluated each day on various parameters, skills & technical knowledge and an exam will be conducted on the last day of training.

Important:

- **1.** Only online applications on the portal shall be accepted. Registration is on first come-first- serve basis.
- 2. Only shortlisted candidates will be notified.
- **3.** A written exam will be conducted at the end of 5th day.
